#### Cities Initiative Receives Governor General Award

The Great Lakes and St. Lawrence Cities Initiative is deeply honored to receive the Canadian Governor General's Medallion for contributions to strengthening relations between Canada and the United States. The presentation by His Excellency David Johnston in Chicago on April 28, 2015 highlighted the Cities Initiative as a "shining example of stewardship and partnership." He went on to note that "representatives from all sectors with a stake in the Great Lakes and St. Lawrence waterways have combined their efforts to preserve this vital natural resource." The Cities Initiative greatly appreciates the recognition from the Governor General.

## US EPA Issues Health Advisory for Toxic Algae Levels

On May 6<sup>th</sup>, the United States Environmental Protection Agency issued a health advisory for safe levels of microcystin (toxic algae) in drinking water supplies. This action follows the growing concern about safe drinking water as spurred by last summer's crisis in Toledo. The advisory, while not a regulation, will help local officials determine the best public health actions as the peak algae bloom season approaches. The advisory levels were established through the best available science and in consultation with Environment Canada. #### Indiana Passes Ban on Microbeads

On Thursday, April 30<sup>th</sup>, Indiana Governor Mike Pence signed House Enrolled Act 1185, which bans the sale or production of products containing microbeads. Indiana joins Illinois as the only Great Lakes states to pass bans on microbeads. Minnesota, Wisconsin, New York, Michigan, and Ontario are in the process of reviewing legislation. Action in Quebec may pick up after a high school student started a petition that caught the eye of a Member of the National Assembly. ### Important Investments at the Port of Montreal

The administration of the Port of Montreal, which held its annual meeting on May 12th, has increased their investment projects. A new \$122 million-dollar container terminal is in construction, which will be the last expansion of the port on the Island of Montreal. The port administration is preparing its next container-handling expansion in the municipality of Contrecoeur, 40 kilometers east of Montreal. This site could accommodate 1.15 million additional containers. In addition, the Port of Montreal continues to search for financing to carry out the restoration of the Iberville passenger terminal and the Alexandra Quay, an investment of 78 million. 45 million dollars of this investment have been announced by the City of Montreal and the government of Quebec, and an announcement from the federal government is expecting in the coming months. ### Grand Rapids Receives Recognition for Recycling Program

The City of Grand Rapids, Michigan, recently received distinction from Governor Rick Snyder for its incentive-based recycling program.
