## Great Lakes Mayors Support Biden-Harris Lead Pipe and Paint Action Plan

CHICAGO, December 16, 2021 – Leading mayors from the Great Lakes and St. Lawrence Cities Initiative announced their support for the Biden-Harris Lead Pipe and Paint Action Plan, announced today at the AFL-CIO Headquarters in Washington, DC.

The Biden-Harris Lead Pipe and Paint Action Plan includes more than 15 new actions, including:

- Collaborating with local, state, and federal partners to accelerate the replacement of lead pipes over the next decade;
- Allocating \$3 billion in Bipartisan Infrastructure Law funding to states, tribes, and territories for lead service line replacement in 2022, and calling on states to prioritize underserved communities;
- EPA launching a new regulatory process to protect communities from lead in drinking water;
- Treasury clarifying that the \$350 billion State and Local Fiscal Recovery Fund provided in the American Rescue Plan can be used for lead service line and lead faucet and fixture replacements;
- EPA and Department of Labor establishing regional technical assistance hubs to fasttrack lead service line removal projects in partnership with labor unions and local water agencies;
- HUD awarding grants to remove lead paint and other home health hazards in lowincome communities to protect children and families;

• CDC closing gaps in childhood lead testing through the Childhood Lead Poisoning Prevention Program.

"President Biden and Vice President Harris made replacing lead pipes a centerpiece of the Bipartisan Infrastructure Law – to deliver clean drinking water to families and children across America, and have delivered on their promise," said Mayor Billy McKinney, Chair of the Great Lakes and St. Lawrence Cities Initiative's Mayors Commission on Water Equity.

"I'm grateful for the Biden-Harris administration's action to eliminate lead pipes and protect our residents," said Chicago Mayor Lori E. Lightfoot. "These transformational investments will put plumbers and pipefitters to work while meeting the critical need for upgrades."

"The Lead Pipe and Paint Action Plan represents an historic effort to deploy catalytic resources from the Bipartisan Infrastructure Law while leveraging every tool across federal, state, and local government to deliver clean drinking water, replacing lead pipes and remediating lead paint," said Detroit Mayor Mike Duggan.

"In addition to activating these investments, the Administration will mobilize existing resources and programs, technical assistance, rulemaking and policies to accelerate progress toward the President's goals," said Milwaukee Mayor Tom Barrett.

"I want to thank the members of the Mayors Commission on Water Equity, led by Mayor McKinney, for their hard work on this critical issue, and their teaming with the Administration to deliver this breakthrough action plan," said Walter Sendzik, Chair of the Great Lakes and St. Lawrence Cities Initiative.
